# 1 Introduction

## 1.1 Aim of the Document

This document provides examples of SWIFT ISO 15022 messages, which are generated by OeKB CSD following the Transaction Management processes under T2S for the Austrian Capital Market.

These examples refer to the document "Using T2S for Transaction Management" being the guideline for applying the T2S standards for Corporate Actions in the Austrian Capital Market.

## 1.2 Contents and Structure of the Document

This document contains examples of SWIFT messages for several scenarios of Market Claim and Transformations.

Chapter 2 contains SWIFT messages in connection with Market Claims/Reverse Claims.

For Claims out of Cash-Distributions OeKB CSD will send the following SWIFT messages:

- \* MT548 Settlement Status and Processing Advice
- \* MT545 or M547 Settlement Confirmation
- \* MT566 Corporate Action Confirmation

For Claims out of Securities-Distributions OeKB CSD will send the following SWIFT messages:

- \* MT548 Settlement Status and Processing Advice
- \* MT544 or M546 Settlement Confirmation

Chapter 3 contains SWIFT messages in connection with Transformations.

For Transformations OeKB CSD will send the following SWIFT messages:

- \* MT548 Settlement Status and Processing Advice
- \* MT544, MT545, MT546 or MT547 Settlement Confirmation

## 2 Market Claims

### 2.1 Market Claim – Example Cash Dividend

#### **Trade Date before Ex Date / pending Settlement Transactions on Record Date**

At EOD on the Record Date the Instruction Owning CSD identifies pending settlement instructions and generates Market Claim instructions for entitled transactions. On the Trade Date the transaction was entered “cum dividend”. Open entitlements have to be transferred “from the Seller to the Buyer”. The Market Claim instructions are forwarded to T2S using sese.023 messages.

### 2.1.2 MT548 Settlement Status and Processing Advice

OeKB CSD sends an MT548 Settlement Status message to the participants informing them of the generation of a Market Claim instruction, which was previously sent to the T2S System in form of a sese.023 message.

In this example of a SWIFT MT548 message both Party Hold and CSD Hold are set. After the release of the CSD Hold another SWIFT MT548 message will be sent indicating the new status.

References in the linkage block:

- **RELA:** This field contains “NONREF” if an instruction is created for an authorized securities account.
- **PCTI:** This field contains the reference of the market claim generated by OeKB CSD. This reference has to be used in case of a cancellation or an amendment of the instruction.
- **PREV:** This field contains the customer reference of the underlying instruction.
- **MITI:** Unique T2S reference of the Market Claim instruction
- **CORP:** Corporate Action Reference

### **2.1.3 MT544-547 Settlement Confirmation**

References in the linkage block:

- **RELA:** This field contains "NONREF" if an instruction is created for an authorized securities account.
- **PCTI:** This field contains the reference of the market claim generated by OeKB CSD.
- **PREV:** This field contains the customer reference of the underlying instruction
- **MITI:** Unique T2S reference of the Market Claim instruction
- **CORP:** Corporate Action Reference

Market Claim specific data in the Mandatory Sequence E Settlement Details:

- :22F: - Type of Settlement Transaction

- **CLAI:** indicates that the instruction results from a Market Claim or Reverse Claim.

Data in the Mandatory Sequence C Financial Instrument/Account:

- **:36B:** - Quantity of Financial Instrument Settled
- **ESTT:** The effective settlement volume.

### 2.1.4 MT566 Corporate Action Confirmation

After the settlement of the Market Claim instruction (MT544-547) OeKB CSD sends a SWIFT MT566 Corporate Action Confirmation message to the CSD participant.

References in the Linkage Block:

- **PREV:** This field contains the reference to the underlying MT564 REPE.
- **RELA:** This field contains the customer reference to the Underlying Settlement Instruction.

Market Claim specific data within the Optional Sequence C Corporate Action Details:

- :22F: ADDB-Indicator: Additional Business Process Indicator
- **CLAI:** in case the Corporate Action Confirmation results from a Market Claim or Reverse Claim.

Market Claim specific data in the Mandatory Sequence B Underlying Securities:

- :93B: - CONB – Confirmed Balance
- **UNIT** or **FAMT:** negative sign (N) within the message to the Seller

## 2.2 Market Claim – Distribution in Securities

### Trade Date Before Ex Date / Pending Settlement Transaction on Record Date

On the record date EOD the instruction owner CSD determines which settlement instructions are pending and generates the corresponding market claim instructions for transactions with entitlements. The transaction was made "cum dividend" on the trade date. In this case, pending entitlements must be transferred "from the seller to the buyer".

The market claim instructions are forwarded to T2S as sese.023 messages.

The market claim instructions for securities to which the status messages relate are free of payment (FOP). Therefore, the settlement confirmations generated will be SWIFT MT544 or MT546 messages.

## 2.3 Reverse Claim - Example Cash Dividend

### Trade Date on/after Ex Date - The Settlement takes place before or/on Record Date

The transaction was entered “Ex-Dividend” after the Trade date. The settlement of the instruction has already taken place before or on the Record Date (shortened settlement period). Therefore the position is already booked on the account of the buyer before Record Date EOD. The entitlement identified on the Record Date has to be transferred “from the Buyer to the Seller”. The Instruction Owning CSD generates a Reverse Claim. Already booked payments have to be transferred “from the Buyer to the Seller” (Reverse Claim). These are sent to T2S in form of a sese.023 message.
